## SECTION 4 - Terms of Application

Applicant:

1. The Applicant's planting site must be within the Kettle Creek watershed.
2. The Applicant understands that seedlings for this program are available to landowners who meet the criteria of KCCA's reforestation goals and objectives and are not for the purposes of landscaping.
3. The Applicant agrees to prepare the site for tree planting as prescribed by the Authority. KCCA reserves the right to withdraw from any planting agreement for which prescribed preparations have not been carried out.
4. The Applicant agrees to:
  - i) Make arrangements to be available for consultation purposes with staff from KCCA;
  - ii) Maintain and protect the planted area from herbaceous growth, destruction by fire and/or pests using mechanical, physical or chemical means as deemed useful by the Landowner, for a period of three years (3) after planting;
  - iii) Permit, upon request, KCCA to conduct site assessments of the planting site;
  - iv) Permit, upon request, KCCA to publicize the location and function of the planting project by the erection of a sign and the utilization of any other media; and
  - v) Maintain the planting project subject to this agreement for 15 years after planting.

Kettle Creek Conservation Authority:

1. The Authority agrees to accept all responsibility for any injuries or damage to staff or Authority equipment respectively, when Authority representatives are accessing the Landowner's property.
2. The Authority agrees to give the Landowner reasonable notice and make any necessary arrangements prior to each needed access.
3. The Authority reserves the right to limit seedling quantities to applicants.
4. The Authority cannot guarantee tree survival.

The Landowner agrees to uphold this agreement and encourage his or her heirs and/or successors to do the same.

The Landowner acknowledges and understands that the information provided within this application is collected by Kettle Creek Conservation Authority (KCCA) under the authority of the *Conservation Authorities Act*, Section 21 for the sole purpose of project administration. This information will be used by KCCA and its funding partners to determine eligibility and for reporting purposes.

I, the undersigned, declare that I have deeded ownership of the property described and that I agree to abide by the Terms of Agreement as set forth above. I hereby authorize Kettle Creek Conservation Authority to order and/or plant trees on my behalf.
