## 2024 Section 28 Permit Timelines and Compliance Annual Report

Ontario Regulation 686/21 (Mandatory Programs and Services) under the Conservation Authorities Act was amended on April 1, 2024, to introduce annual reporting requirements for Conservation Authorities. Under section 8.1 of the regulation, all Conservation Authorities must prepare and publish an annual report detailing permit statistics. This includes reporting on compliance with Ontario Regulation 41/24, which governs permit applications, issuance, and associated timelines.

For the purpose of determining permit decision timelines, applications are categorized as **major** (requiring significant staff review of technical documents i.e. large subdivision) and **minor** (limited scale/scope or work with minimal impacts on the control of flooding, erosion, dynamic beaches or unstable soil or bedrock). A decision on major applications must be made within **90 days** of receipt of a complete application and a decision on minor applications must be made within **30 days** of receiving a complete application. Conservation Ontario's Client Service Standards promotes making a decision on major applications within **28 days** after receipt of a complete major application and within **14 days** after receipt of a minor application.

## Highlights for 2024

- KCCA issued 48 permits in 2024; 28 minor and 20 major
- 100% of the major permits were issued within the 90-day legislated timeline and 95% were issued within 30 days of receiving a complete application meeting or exceeding the Conservation Ontario Client Service Standard
- 100% of the minor permits were issued within the 30-day legislated timeline and 82% were issued within 14 days of receiving a complete application meeting or exceeding the Conservation Ontario Client Service Standard
